

It is further ordered that paragraph 6 of the Stipulation and Order Regarding Protocol for Privileged Material (No. 17-cv-04180, ECF No. 75) is modified to read as follows:

6. Privilege logs of documents identified or reviewed prior to productions and withheld from such productions based on privilege grounds shall be served ninety (90) days following any such productions, but no later than October 28, 2019 for any productions served on or before September 27, 2019. The parties shall meet and confer in good faith to determine the deadline for any productions occurring after September 27, 2019.
