STIPULATION AND [PROPOSED] ORDER

Plaintiff Coherus BioSciences, Inc. ("Coherus") and Defendants AbbVie Inc. and AbbVie Biotechnology Ltd. ("AbbVie") (collectively, "the Parties") hereby stipulate and agree by and through their undersigned counsel, subject to the approval of the Court, as follows:

- 1. AbbVie stipulates that it will not terminate the Parties' Settlement and License Agreement ("Agreement") without first serving on Coherus a new notice of breach pursuant to Section 10 of the Agreement, and affording Coherus at least seven (7) days to cure. AbbVie will not seek to terminate the Agreement based on the notice of breach provided in Abbvie's letter to Coherus dated June 6, 2023.
- 2. Coherus agrees to withdraw its Motion for Temporary Restraining Order filed on June 13, 2023 ("Motion"). In the event AbbVie serves a new notice of breach pursuant to Section 10 of the Agreement, Coherus reserves the right to bring a new Motion for Temporary Restraining Order.
